## SPECIAL POWER OF ATTORNEY

Zachary Critchett ("Principal"), whose address is PO Box 2444, La Pine, Oregon 97739, makes this Special Power of Attorney ("Power of Attorney") to grant authority to Mathew Smith ("Agent"), whose address is 56239 Bufflehead Rd., Bend, Oregon 97707, to act as Principal's agent for the limited and specific purposes set forth in this Power of Attorney.

## 1. Definitions.

- (a) "Company" means TFR Properties, LLC, an Oregon limited liability company.
- (b) "Transactions" means all of the following:

- **4. Powers.** With respect to all authorized acts, Agent has the power to:
  - (a) To execute all loan documents, guarantor documents, deeds, easements, contracts, and other documents or instruments necessary or proper related to the Company and/or Transactions;
  - (b) seek on Principal's behalf the assistance of a court to carry out an act authorized by Principal in this Power of Attorney;
  - (c) engage, compensate, and discharge an attorney, accountant, expert witness, property or building inspector, or other assistant;

- (d) prepare, execute, and file a record, report, or other document Agent considers desirable to safeguard or promote Principal's interest under a statute or governmental regulation;
- (e) communicate with any representative or employee of a government, governmental subdivision, agency, or instrumentality on behalf of Principal; and
- (f) access communications intended for and communicate on behalf of Principal, whether by mail, e-mail, telephone, or other means.
- 5. When Effective. This Power of Attorney will become effective on signing by Principal.
- 6. Termination. This Power of Attorney will terminate on 31 Occurred 2019.
- 7. Reliance. Any person, including Agent, may rely upon the validity of this Power of Attorney or a copy of it unless that person knows it has not become effective or is terminated or invalid.
