THE COUNTY CLERK OF KLAMATH COUNTY, OREGON.

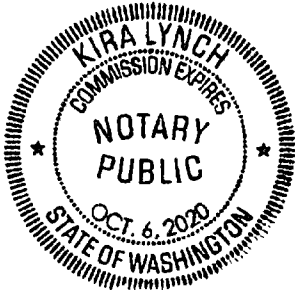

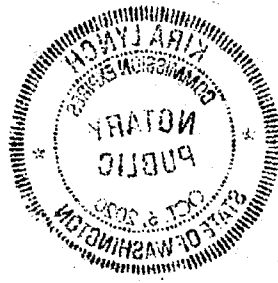
