KNOW ALL MEN BY THESE PRESENTS, that I, JO ANN GOOCH have made, constituted and appointed and by these presents do make, constitute and appoint RYAN CARNEY POPE my lawful attorney, for me and in my name, place and stead and for my use and benefit,

- 1) To lease, let, grant, bargain, sell, contract to sell, convey exchange, remise, release and dispose of any real or personal property of which I am now or hereafter may be possessed or in which I may have any right, title or interest, including rights of homestead, for any price or sum and upon such terms and conditions as to my said attorney may seen proper;
- 2) To take possession of, manage, maintain, operate, repair and improve any and all real or personal property now or hereafter belonging to me, to pay the expense thereof, to insure and keep the same insured and to pay any and all taxes, charges and assessments that may be levied or imposed upon any thereof;
