BARGAIN AND SALE DEED

1. PARTIES: The parties to this deed are JANIS F. FISKE and CAROL L. JOHNSON, duly acting Co-Trustees of the RICHARD A. FISKE AND JANIS F. FISKE REVOCABLE LIVING TRUST dated 4/30/1996, as restated and amended, Grantors, and CAROL L. JOHNSON and JOY L. TAYLIN, as Co-Trustees of the RICHARD A. FISKE IRREVOCABLE TRUST, Grantees.

2. RECITALS: On April 30, 1996, Richard F. Fiske and Janis F. Fiske, as Trustors, transferred to Richard A. Fiske and Janis F. Fiske, as Trustees of the Richard A. Fiske and Janis F. Fiske Revocable Living Trust (the "Trust"), certain items of real and personal property. On February 25, 2016, the Trustors executed a restatement of the Trust, naming Janis F. Fiske, Carol L. Johnson and Joy L.
