The true and actual consideration for this conveyance is \$345,000.00.

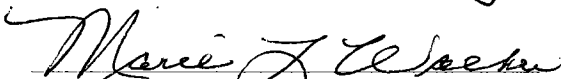

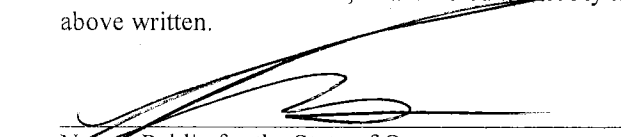
