The true and actual consideration for this conveyance is \$225,000.00.

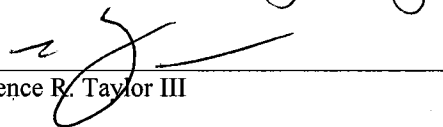

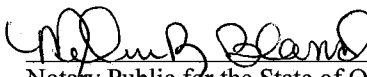
