The true and actual consideration for this conveyance is \$329,000.00.

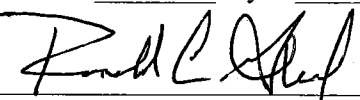

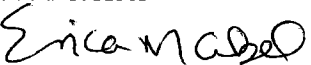

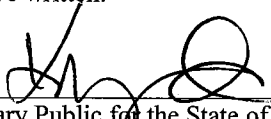
