THIS INDENTURE, Made this 07/13/2018, by and between Chris Kaber, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and NATIONSTAR MORTGAGE, hereinafter called the grantee;  
WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 16CV16428, Klamath County Sheriff's Office Number F17-0154, in which NATIONSTAR MORTGAGE was plaintiff(s) and THE ESTATE OF DARMON A. 
