SECOND PARTIES: Gregory A. Ferr & Shelly L. Ferr who own real property described as:

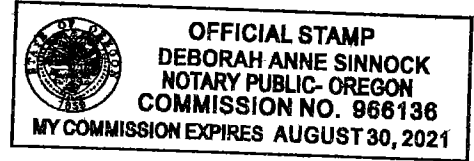
