## RELINQUISHMENT AND CREATION OF IRRIGATION EASEMENT

We, Scott Farrar (Owner of Lot 4, Block 1 of Plat of Subdivision of Blocks 2B and 3 of Homedale), Donald D. Boner (Owner of Lot 5, Block 1 of Plat of Subdivision of Blocks 2B and 3 of Homedale), and Shane McDonald (Manager of Enterprise Irrigation District) hereby relinquish an existing easement and create a new irrigation easement on said Lots 4 and 5, Block 1 of Plat of Subdivision of Blocks 2B and 3 of Homedale, situated in the NE1/4 NE1/4 of Section 11, T39S, R9EWM, Klamath County, Oregon, being more particularly described as follows:

Legal description of easement being relinquished by this document:

The apparent irrigation easement depicted on said Lots 4 and 5, Block 1 of said Plat of Subdivision of Blocks 2B and 3 of Homedale. The easement is visually mapped on said plat in a northwesterly-southeasterly direction but is not verbally described on said plat. This easement; presumed, prescriptive or otherwise, is hereby relinquished.

Legal description of irrigation easement being created by this document:

The northerly 10 (ten) feet of said Lots 4 and 5, Block 1 of said Plat of Subdivision of Blocks 2B and 3 of Homedale.

The period of this easement shall be for perpetuity. This easement shall bind and inure for the benefit of, as the circumstances may require, not only to the Grantors, but also to their heirs, successors and assigns. This easement shall be for the benefit of the land herein described as well as Enterprise Irrigation District.
