**PROPERTY LINE ADJUSTMENT DEED**

The true consideration for this conveyance is to complete "Property Line Adjustment 7-18". The purpose of this deed is to provide an accurate legal description of the subject property as adjusted by the Property Line Adjustment.

I, Donald D. Boner, Grantor, conveys to, Donald D. Boner, Grantee, the following described real property situated in Klamath County, Oregon, to-wit:

LOT 5, BLOCK 1 OF "PLAT OF SUBDIVISION OF BLOCKS 2B AND 3 OF HOMEDALE", ACCORDING TO THE OFFICIAL PLAT THEREOF ON FILE IN THE OFFICE OF THE COUNTY CLERK, KLAMATH COUNTY OREGON,

EXCEPTING THEREFROM THE SOUTH 5 FEET THEREOF CONVEYED TO TO KLAMATH COUNTY FOR ROAD PURPOSES BY VOLUME 362 AT PAGE 561, DEED RECORDS OF KLAMATH COUNTY, OREGON.

ALSO EXCEPTING THEREFROM:

A TRACT OF LAND BEING A PORTION OF LOT 5 IN BLOCK 1 OF "PLAT OF SUBDIVISION OF BLOCKS 2B AND 3 OF HOMEDALE", SITUATED IN THE NE1/4 NE1/4 OF SECTION 11, T39S, R9EWM, KLAMATH COUNTY, OREGON, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

RAILROAD FROM WHICH THE NORTHEAST CORNER OF PARCEL 1 OF MINOR PARTITION 82-83 BEARS S66°42'00"E 338.50 FEET; THENCE ALONG THE SAID SOUTHERLY RIGHT OF WAY LINE N66°42'00"W 66.32 FEET; THENCE LEAVING SAID SOUTHERLY RIGHT OF WAY LINE S31°04'00"E 89.33 FEET; THENCE S14°44'00"E 46.92 FEET; THENCE S00°17'00"W 186.72 FEET; THENCE N01°00'42"E 103.65 FEET; THENCE N00°37'56"E 178.76 FEET TO THE POINT OF BEGINNING; CONTAINING 0.06 ACRES, MORE OR LESS AND WITH BEARINGS BASED ON SAID PLAT OF SUBDIVISION OF BLOCKS 2B AND 3 OF HOMEDALE, KLAMATH COUNTY, OREGON.

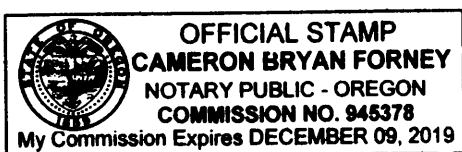
