The true and actual consideration for this conveyance is \$153,500.00.

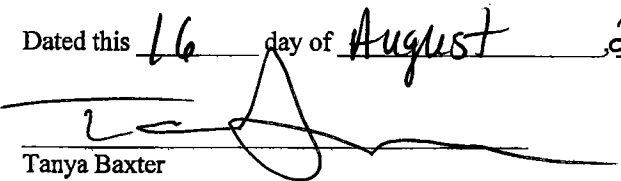

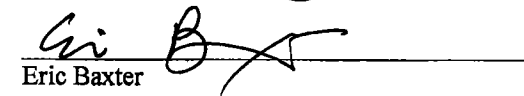

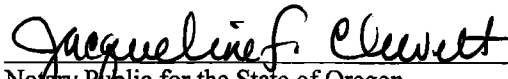
