KNOW ALL BY THESE PRESENTS that Klamath County, a political subdivision of the State of Oregon hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and forever quitclaim unto **Thomas D. Rogers, Sr.**, hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, State of Oregon, described as follows, to-wit:

Description of real property: Parcel 1: That portion of Lot 1, Block 16, Klamath Falls Forest Estates Sycan Unit, according to the official plat thereof on file in the office of the County Clerk, Klamath County, Oregon, described as follows: Beginning at the SE corner of Lot 1; thence N along the E line 430 feet; thence W to the Westerly line of said lot; Thence Southerly along said Westerly line of said lot to the South line thereof; thence Easterly along said Southerly line of said lot to the point of beginning, Parcel 2: Klamath Falls Forest Estates Sycan Unit, The Northerly 549.07' M/L of the Easterly 700' M/L of Lot 2, Block 16, acres 9.16, according to the official plat thereof on file in the office of the County Clerk, Klamath County, Oregon. Subject to covenants, conditions, restrictions, easements, reservations, rights, rights of way and all matters appearing of record.

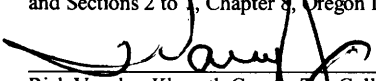
To Have and to Hold the same unto grantee and grantee's heirs, successors and assigns forever.

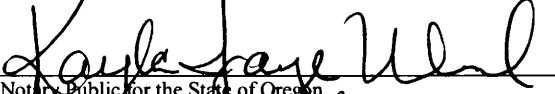
