The NW1/4 of Section 22 in Township 39 South, Range 12 East of the Willamette Meridian, Klamath County, Oregon.

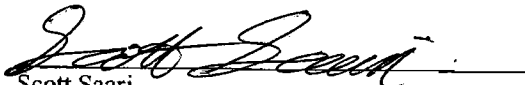

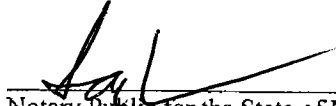
