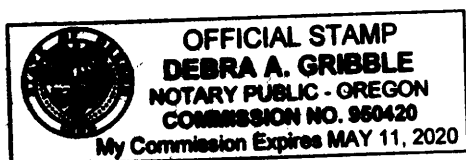

Plaintiff, Klamath County, Oregon (County), is a duly organized county of the State of Oregon and body politic and corporate under and by virtue and laws of the State of Oregon and is acting through its Senior Chief Deputy Tax Collector, Linda Bacchi, pursuant to ORS 312.050

2.

The above named defendants include each and every person appearing on the latest tax roll as the owner or owners of the several properties listed in the foreclosure list described below and incorporated herein. These defendants, including any owners unknown to plaintiff, have or claim to have some interest or estate in the several properties described in the foreclosure list.

3.

The Tax Collector of the County maintains a foreclosure list of all county properties subject to foreclosure for delinquent taxes as of August 16, 2018. The foreclosure list was prepared pursuant to and in accordance with ORS 312.030 and contains all the information required by this statute. All property descriptions are in accordance with ORS 312.040 and ORS 308.240. A copy of the foreclosure list is attached hereto as "Exhibit A" and is by this reference incorporated herein. Where any reference is made to an Assessor's tax lot number in describing any parcel of property in the foreclosure list, such reference is to the record made and kept by the Assessor of Klamath County, Oregon, of descriptions of property for such County, which record constitutes a public record by virtue of ORS 308.215 et seq.

4.

The foreclosure list includes all properties appearing on the tax rolls in the office of the Tax Collector of the County

and are subject to foreclosure for delinquent taxes whenever three years have elapsed from the earliest date of delinquency of taxes levied and charged thereon, which have not been paid. By reason of the expiration of three years from the earliest date of delinquency, together with all special assessments, fees or other charges charged against these properties subject to foreclosure, which are due and unpaid for any year or years for which ad valorem taxes are delinquent, the liens of all such delinquent taxes, special assessments, fees or other charges against each of the several properties included in the said foreclosure list have become subject to foreclosure under the provision of ORS Chapter 312.

5.

The amounts shown by the foreclosure list to be due and owing against the several parcels of property described therein include all taxes for 2017 and prior years which were unpaid and delinquent as of August 16, 2018, together with the accrued interest thereon. The several defendants and each and every other person owning or claiming to own, or having or claiming to have any interest in any of the properties have neglected and refused to pay such delinquent amounts and interest and that there is due, and unpaid to Plaintiff, Klamath County, the respective sums set out in the foreclosure list after the description of each of the several properties and in addition thereto, interest on each of said sums at the rate of 1.333 percent per month from the years of delinquency and subsequent tax years, with said interest accruing through September 15, 2018.

6.

Each of the properties described in the foreclosure list was fully listed for taxation in or for each of the specified years. The assessments, equalization, levies of taxes, notification procedures and all other acts required by law to make such taxes first liens on said properties were duly and regularly made and done, and the liens and claims of plaintiff to each of the several properties are first liens and paramount to any other interest, title estate or claim in or on any of said properties. The claims or interest of all defendants including unknown owners, are inferior to and subject to the tax liens of Klamath County.

WHEREFORE, Plaintiff prays for judgment of this court, pursuant to ORS 312.060, as follows:

- For the full amount of taxes and interest, special assessments, fees or other charges charged against each of the several properties included in said foreclosure list, together with interest thereon at the rate of 1.333 percent per month from the years of delinquency and subsequent tax years, to the date of such judgment, and accruing interest on said judgment at the legal rate of interest.
- That the liens and claims of plaintiff to each of the several properties are first liens and paramount to any other interest, title, estate or claim in or on any of said properties made or potentially made by any other person or entity, known or unknown.
- That the several liens detailed in this Application are hereby forever foreclosed, subject only to lawful redemption as detailed by statute.
- That the resulting judgment is a several judgment against and a lien upon each parcel of property detailed in this Application.
- Directing the clerk of the court to serve on the tax collector of Klamath County a certified copy of the judgment, included in which shall be a list of the properties so ordered sold, with the several amounts due thereon and that said judgment, so delivered to the tax collector, shall constitute and be considered for all intents and purposes a certificate of sale to Klamath County for each of the properties therein described.
- That this court shall retain jurisdiction to enforce the terms of this judgment with respect to the foreclosed properties identified in Supplemental Tax Foreclosure List and that a Writ of Assistance or Writ of Execution may issue to obtain possession of said foreclosed properties upon a showing that possession is being unlawfully withheld from Klamath County.
- That said tax collector and Klamath County may take further steps in this matter as are provided by law.
