- A. On or about June 20, 2014, Harry A. Caldwell and Debra L. Caldwell issued an Installment Note to Joyce C. Sellars in the principal sum of \$125,000.
- B. On or about June 20, 2014, Harry A. Caldwell and Debra L. Caldwell issued a Second Trust Deed to Joyce C. Sellars to secure payment of the above described Installment Note.
 - C. Joyce C. Sellars died March 28, 2015.
- D. On or about May 29, 2015, Michael J. Sellars, Terry R. Sellars and Robert D. Sellars were appointed as Joint Personal Representatives of the Estate of Joyce C. Sellars by the Klamath County Circuit Court under Case No. 1501775CV.
- E. On or about July 2, 2015, Joyce C. Sellars' Payee/Seller's interest in the aforedescribed Installment Note was assigned to the Estate of Joyce C. Sellars, the beneficial interest in that Second Deed of Trust was not assigned, but remains with the Estate of Joyce C. Sellars following Joyce C. Sellars' death.

WHEREFORE

Michael J. Sellars, Terry R. Sellars and Robert D. Sellars, Joint Personal Representatives of the Estate of Joyce C. Sellars, Klamath County Circuit Court Case No. 1501775CV, pursuant to an order issued by said court dated April 18, 2018, do grant, assign and transfer a one-third interest each to each of said named Assignees, the interest of the Beneficiary (Joyce C. Sellars) of that Second Deed of Trust dated June 20, 2014, made by Harry A. Caldwell and Debra L. Caldwell as Grantors, in favor of First American Title, as Trustee, for the benefit of Joyce C. Sellars, as Beneficiary recorded on June 23, 2014, in the records of the Clerk of Klamath County, Oregon as Document No. 2014-006670.

Assignor owns all of the beneficial interest under said Trust Deed and is the holder of the Installment Note dated June 20, 2014 in the face amount of \$125,000, which the Second Trust Deed secures. Said Installment Note is simultaneously being assigned from the Estate of Joyce C. Sellars to Michael J. Sellars as to a one-third interest, Terry R. Sellars as to a one-third interest and Robert D.
