The true and actual consideration for this conveyance is \$335,000.00.

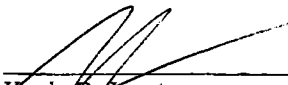

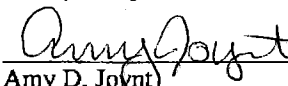

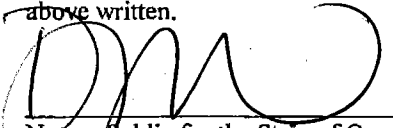
