The true and actual consideration for this conveyance is \$13,500.00.

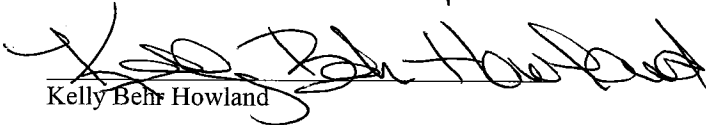

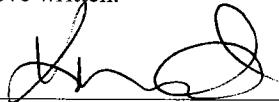
