THIS INDENTURE, Made this 09/13/2018, by and between Chris Kaber, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and JPMORGAN CHASE BANK, NATIONAL ASSOCIATION, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 15CV23328, Klamath County Sheriff's Office Number F18-0206, in which JPMORGAN CHASE BANK, NATIONAL ASSOCIATION, ITS SUCCESSORS IN INTERESTS AND/OR ASSIGNS was plaintiff(s) and TRENTON C. KOLOSKI AKA TRENTON COLE KOLOSIK; GENERAL CREDIT SERVICE, INC.; AND OCCUPANTS OF THE PREMISES was defendant(s), in which a Writ of Execution, which was issued on 01/25/2018, directing the sale of that real property, pursuant to which, on 03/14/2018 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$64,000.00, to JPMORGAN CHASE BANK, N.A., who was the highest and best bidder, that sum being the highest and best sum bid therefore. 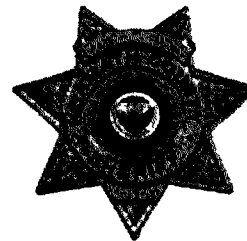
