THIS INDENTURE, Made this 09/26/2018, by and between Chris Kaber, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and U.S. BANK NATIONAL ASSOCIATION, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 15CV34305, Klamath County Sheriff's Office Number F17-0176, in which U.S. BANK NATIONAL ASSOCIATION was plaintiff(s) and UNKNOWN TRUSTEE, AS TRUSTEE OF THE RONALD D. PLANTS LIVING TRUST, DATED SEPTEMBER 2, 2010; THE UNKNOWN BENEFICIARIES OF THE RONALD D. PLANTS LIVING TRUST, DATED SEPTEMBER 2, 2010; THE ESTATE OF RONALD D.
