The true and actual consideration for this conveyance is \$265,000.00.

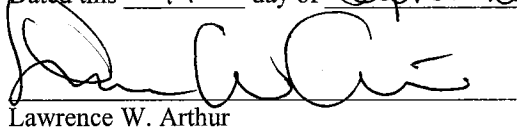

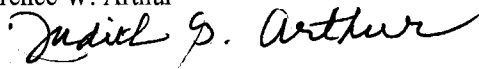

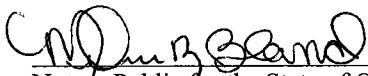
