The true and actual consideration for this conveyance is \$295,000.00.

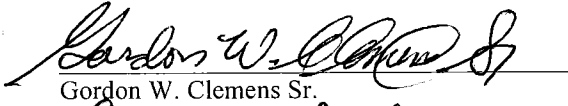

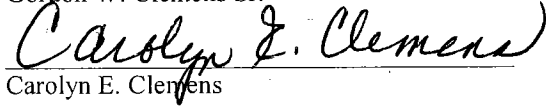

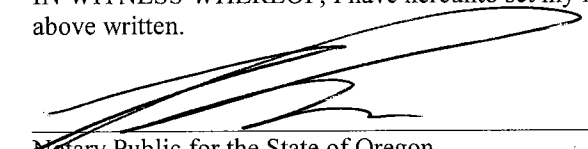
