The true and actual consideration for this conveyance is \$177,500.00.

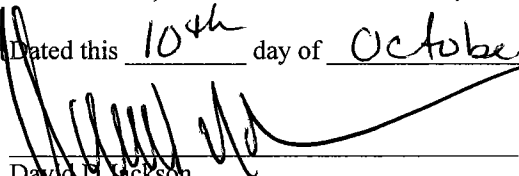

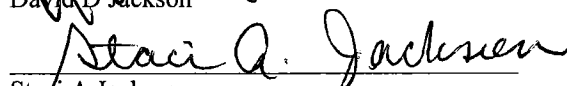
