A parcel of land situate in the S1/2 NW1/4 of Section 21, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, described as follows:

Beginning at a point in the center line of Morningside Lane, a 40 foot roadway, from which the Northwesterly corner of the SW1/4 NW1/4 of Section 21, Township 39 South, Range 9 East of the Willamette Meridian, bears South 88°50 1/2' West along the Center line of the said Morningside Lane, 1435.0 feet, and North 0°10' East along the Westerly boundary of the said Section 21, 858.0 feet, and running thence South 0°10' West 505.2 feet, more or less, to a point in the Southerly boundary of the S1/2 NW1/4 of said Section 21; thence North 88°48' East along the said boundary line 160.0 feet; thence North 0°10' East 505.0 feet, more or less, to a point in the center line of the said Morningside Lane; thence South 88°50 1/2' West along the said center line 160.0 feet, more or less, to the point of beginning.
