Grantee(s), the following described real property in the County of Klamath and State of Oregon free of encumbrances except as specifically set forth herein:

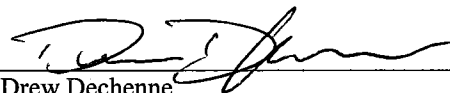
Lot 4 in Block 2, RIVER RANCH ESTATES, according to the official plat thereof on file in the office of the County Clerk, Klamath County, Oregon.

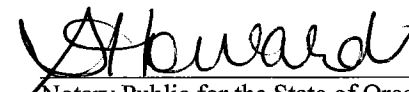
