ASSIGNMENT OF NOTE AND TRUST DEED

DATED: October 15, 2018

**PARTIES: Assignor: Ciara Marshall and Shiaynne Marshall, Co-Trustees of the
Mihailov Family Living Trust dated October 20, 2009**

Assignee: Ciara Marshall, Shiaynne Marshall, and Derek Marshall

RECITALS:

A. Assignor is the owner of one-hundred percent (100%) of the beneficial interest in a certain Trust Deed dated March 1, 2016, originally between **Rick K. Cook**, as Grantor, and **AmeriTitle, an Oregon Corporation**, as Trustee, and **Barry L. Mihailov**, as Trustee of the **Mihailov Family Trust, dated October 20, 2009**, as Beneficiary, which Trust Deed was recorded March 4, 2016, as Document No. 2016-002430 in the Official Records of Klamath County, Oregon, hereinafter be described as "the Trust Deed," and describing land therein as:

**The SW1/4 of the NW1/4 of the SW1/4 of Section 31, Township 35 South, Range 13
East of the Willamette Meridian, Klamath County, Oregon.**

B. The Assignor is the holder and owner of one-hundred percent (100%) beneficial interest in a Note dated March 1, 2016, in the original amount of \$9,000.00 and made by **Rick K. Cook** as the borrower. This note is secured by the Trust Deed described above and shall hereinafter be described as "the Note."


C. By the terms of the **Mihailov Family Living Trust dated October 20, 2009**, **Barry Lee Mihailov** and **Terry Ann Mihailov** are named as the initial Trustees. If both **Barry Lee Mihailov** and **Terry Ann Mihailov** are unable or unwilling to serve as such Trustee, then **Ciara Marshall** and **Shiaynne Marshall** are named to serve as Successor Co-Trustees. Each Successor Co-Trustee so appointed shall have all powers granted to a Trustee and may act individually and severally and without the permission or consent of any other Co-Trustee serving at the same time. As **Terry Ann Mihailov** died in 2012, and **Barry Lee Mihailov** died on December 13, 2017, **Ciara Marshall** and **Shiaynne Marshall** are currently acting as Co-Trustees and have all powers granted to a trustee.

ASSIGNMENT:



Henceforth, the Assignee shall have all rights of the Assignor under the Trust Deed and the right to collect all sums becoming due under the Note.

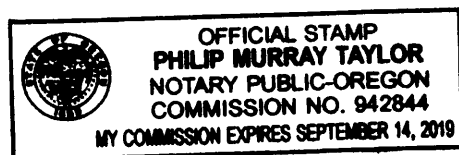


