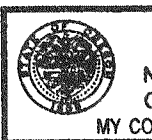

THIS INDENTURE, Made this 10/15/2018, by and between Chris Kaber, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and BANK OF AMERICA, N.A., hereinafter called the grantee;

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 15CV23657, Klamath County Sheriff's Office Number F17-0110, in which BANK OF AMERICA, N.A. was plaintiff(s) and JENNIFER C. 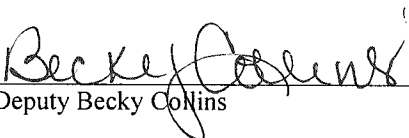

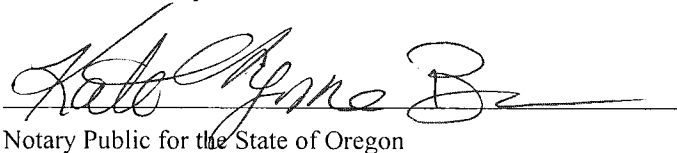
