The true and actual consideration for this conveyance is \$259,900.00.

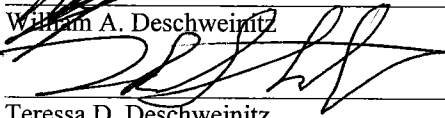

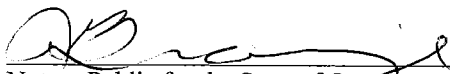
