MODIFICATION OF DEED OF TRUST

THIS MODIFICATION OF DEED OF TRUST dated October 26, 2018, is made and executed between Klamath Falls Center, LLC, an Oregon Limited Liability Company ("Grantor") and Pacific Crest Federal Credit Union, whose address is P O Box 1179, Klamath Falls, OR 97601 ("Lender").

DEED OF TRUST. Lender and Grantor have entered into a Deed of Trust dated June 11, 2009 (the "Deed of Trust") which has been recorded in Klamath County, State of Oregon, as follows:

Modification of Deed of Trust dated 6-8-2012 recorded on 6-11-2012 #'s 2012-006356 & 2012-006357

Modification of Deed of Trust dated 10-30-2012 recorded on 10-30-2012 #2012-012007

Modification of Deed of Trust dated 10-30-2013 recorded on 10-29-2013 #2013-12169.

REAL PROPERTY DESCRIPTION. The Deed of Trust covers the following described real property located in Klamath County, State of Oregon:

The Real Property or its address is commonly known as Raw Land, Klamath Falls, OR 97603.

MODIFICATION. Lender and Grantor hereby modify the Deed of Trust as follows:

90 day extension maturing on 1/30/2019. The borrowers will continue to make the monthly payments of \$7,840.56 due on the 30th of each month until maturity. Remaining amortization is 15 years. All other terms remain the same.

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Deed of Trust shall remain unchanged and in full force and effect. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Deed of Trust as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Deed of Trust (the "Note"). It is the intention of Lender to retain as liable all parties to the Deed of Trust and all parties, makers and endorser to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Deed of Trust does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.

GRANTOR ACKNOWLEDGES HAVING READ ALL THE PROVISIONS OF THIS MODIFICATION OF DEED OF TRUST AND GRANTOR AGREES TO ITS TERMS. THIS MODIFICATION OF DEED OF TRUST IS DATED OCTOBER 26, 2018.

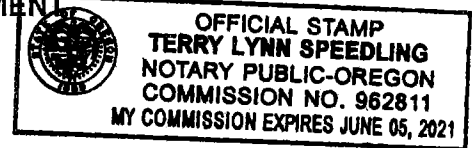
