THIS INDENTURE, made 10/22/2018, between CLEAR RECON CORP
hereinafter called trustee, and BANK OF AMERICA, N.A., hereinafter called the second party:

WITNESSETH:

RECITALS: ROBERT A MARTIN, AND JANE MARTIN, AS TENANTS BY THE ENTIRETY, as grantor, executed and delivered to RECON TRUST COMPANY, N.A., for the benefit of BANK OF AMERICA, N.A., as beneficiary, a certain Trust Deed dated 11/15/2013, duly recorded on 11/25/2013, as Instrument No. 2013-013104,, in the mortgage records of Klamath County, Oregon.

In said Trust Deed the real property therein and hereinafter described was conveyed by said grantor to said trustee to secure, among other things, the performance of certain obligations of the grantor to the said beneficiary. The said grantor thereafter defaulted in his performance of the obligations secured by said Trust Deed as stated in the Notice of Default hereinafter mentioned and such default still existed at the time of the sale hereinafter described.

By reason of said default, the owner and holder of the obligations secured by said Trust Deed, being the beneficiary therein named, or his successor in interest, declared all sums so secured immediately due and owing; a Notice of Default, containing an election to sell the said real property and to foreclose said Trust Deed by advertisement and sale to satisfy grantor's said obligations was recorded in the mortgage records of said county on 6/7/2018 as Instrument No 2018-006885 in book/reel/volume . at page thereof, to which reference now is made.

After the recording of said Notice of Default, as aforesaid, CLEAR RECON CORP the undersigned trustee gave notice of the time for and place of sale of said real property as fixed by the trustee and as required by law. Copies of the Trustee's Notice of Sale were served pursuant to ORCP 7D(2) and 7D(3) or mailed by both first class and certified mail with return receipt requested, to the last-known address of the persons or their legal representatives, if any, named in ORS 86.76, at least 120 days before the date the property was sold, and a copy of the Trustee's Notice of Sale was mailed by first class and certified mail with return receipt requested, to the last-known address of the guardian, conservator or administrator or executor of any person named in ORS 86.76440(1), promptly after the trustee received knowledge of the disability, insanity or death of any such person. Copies of the Trustee's Notice of Sale was served in accordance with ORS 86.774(1) upon the occupants of the property described in the trust deed at least 120 days before the date the property was sold.

KLAMATH PROJECT A-3 LATERAL; THENCE ALONG THE ARC OF A 175.99 FOOT RADIUS CURVE TO THE RIGHT (DELTA= 36° 33' 06"; LONG CHORD= SOUTH 83° 31' 47" WEST, 110.38 FEET) 112.27 FEET TO A 1/2 INCH IRON PIN AT THE END OF CURVE; THENCE NORTH 78° 11' 40" WEST CONTINUING ALONG SAID LATERAL RIGHT OF WAY LINE, 82.94 FEET TO A 1/2 INCH IRON PIN AT THE INTERSECTION OF SAID LATERAL RIGHT OF WAY LINE WITH THE EASTERLY RIGHT OF WAY LINE OF SOUTH ETNA STREET, A COUNTY ROAD; THENCE ALONG SAID EASTERLY RIGHT OF WAY LINE AND THE ARC OF A 170.73 FOOT RADIUS CURVE TO THE LEFT (DELTA=53° 41' 18"; LONG CHORD= NORTH 83° 50'39" WEST, 154.19 FEET) 159.78 FEET TO THE END OF SAID CURVE; THENCE NORTH 57° 00' 00" WEST, 14.76 FEET TO A 1/2 INCH IRON PIN; THENCE LEAVING SAID EASTERLY RIGHT OF WAY LINE NORTH 78° 30' 37" EAST, 239.41 FEET TO THE POINT OF BEGINNING.
