THIS INDENTURE, Made this 11/20/2018, by and between Chris Kaber, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and MIKA N. BLAIN, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 16CV40984, Klamath County Sheriff's Office Number F18-0214, in which ENTERPRISE IRRIGATION DISTRICT was plaintiff(s) and ANTHONY RAY VELASQUEZ; CHRISTINA R. VELASQUEZ; STATE OF OREGON, DEPARTMENT OF JUSTICE; FRANK W. VELASQUEZ; AND MARIA VELASQUEZ was defendant(s), in which a Writ of Execution, which was issued on 02/08/2018, directing the sale of that real property, pursuant to which, on 04/25/2018 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$9,424.35, to ENTERPRISE IRRIGATION DISTRICT, who was the highest and best bidder, that sum being the highest and best sum bid therefore. 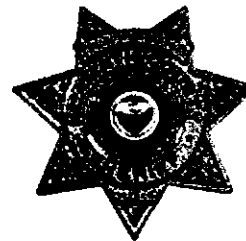
