THIS INDENTURE, Made this 12/12/2018, by and between Chris Kaber, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and JPMORGAN CHASE BANK, NATIONAL ASSOCIATION, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 17CV35148, Klamath County Sheriff's Office Number F18-0211, in which JPMORGAN CHASE BANK, NATIONAL ASSOCIATION was plaintiff(s) and JOCELYN L. 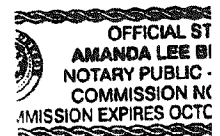

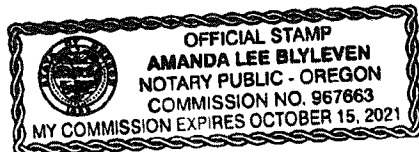

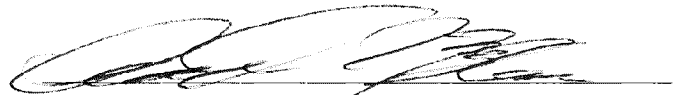
