THIS INDENTURE, Made this 12/20/2018, by and between Chris Kaber, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and DOUGLAS R. KERR AND JENNIFER A. KERR, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 17CV04426, Klamath County Sheriff's Office Number F17-0186, in which DITECH FINANCIAL LLC was plaintiff(s) and DEBBIE R. BROWN, AN INDIVIDUAL; RICHARD E. BROWN, AN INDIVIDUAL; AND ALL OTHER PERSONS, PARTIES, OR OCCUPANTS UNKNOWN CLAIMING ANY LEGAL OR EQUITABLE RIGHT, TITLE, ESTATE, LIEN, OR INTEREST IN THE REAL PROPERTY DESCRIBED IN THE COMPLAINT HEREIN, ADVERSE TO PLAINTIFF'S TITLE, OR ANY CLOUD ON PLAINTIFF'S TITLE TO THE PROPERTY was defendant(s), in which a Writ of Execution in Foreclosure, which was issued on 11/01/2017, directing the sale of that real property, pursuant to which, on 02/21/2018 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$70,074.00, to DOUG AND JENNIFER KERR, who was the highest and best bidder, that sum being the highest and best sum bid therefore. 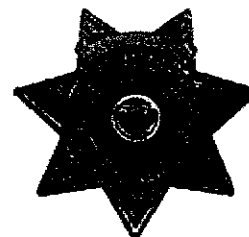
