THIS INDENTURE, Made this 01/17/2019, by and between Chris Kaber, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and PELICAN BLUFF LLC, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 1403708CV, Klamath County Sheriff's Office Number J15-0085, in which Bullet Rental & Sales was plaintiff(s) and DAVID MASTERS, MARYELLEN MASTERS, PHYLLIS A. 


