## FIRST AMENDMENT OF TRUST DEED

THIS FIRST AMENDMENT OF TRUST DEED (this "Amendment") is made effective as of January 10, 2019 by and among Tyler Rickey as **Grantor**, AmeriTitle, a Delaware corporation, as **Trustee**, and Gregory D. Mathis and Susan M. Mathis Trustees of the Mathis Family Living Trust u/t/d September 7,1995 as **Beneficiary**.

WHEREAS, on or about July 19, 2018, Beneficiary made a loan to Grantor in the sum of \$75,000.

WEREAS, Grantor and Beneficiary have amended the promissory note between them as of January 10, 2019 (hereinafter, the "Note"), increasing the principal balance of the Note to \$125,000.

WHEREAS, the parties desire to amend the Trust Deed, dated July 19, 2018 and recorded in the Klamath County Official Records as 2018-008903 on July 27, 2018 (the "Trust Deed"), to correspond to the amendment of the Note.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the parties hereby agree as follows:

1. The third paragraph of the Trust Deed.is hereby replaced in its entirety by the following:

FOR THE PURPOSE OF SECURING PERFORMANCE OF EACH AGREEMENT OF GRANTOR HEREIN CONTAINED AND PAYMENT OF THE SUM OF \$125,000, WITH INTEREST THEREON ACCORDING TO THE TERMS OF A PROMISSORY NOTE DATED JULY 19, 2018, AS AMENDED ON JANUARY 10, 2019, PAYABLE TO BENEFICIARY OR ORDER AND MADE PAYABLE BY GRANTOR, THE FINAL PAYMENT OF PRINCIPAL AND INTEREST HEREOF, IF NOT SOONER PAID, TO BE DUE AND PAYABLE ON JULY 17,2019.

2. Thereafter in the Trust Deed and all amendments and attachments thereto, where the principal balance is referenced as \$75,000, it will be deemed to be \$125,000.

The Trust Deed shall continue in full force and effect, subject to the terms and provisions amended herein. In the event of any conflict between the terms of the Trust Deed and this Amendment, the terms of this Amendment shall control. This Amendment and the Trust Deed shall be binding upon and inure to the benefit of the Grantor, Trustee and Beneficiary and their respective successors and permitted assigns. All capitalized terms used herein shall have the meaning ascribed to them in the Trust Deed, except as modified herein.
