THIS INDENTURE, Made this 11/15/2018, by and between Chris Kaber, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and KEYBANK NATIONAL ASSOCIATION, hereinafter called the grantee; WITNESSETH:

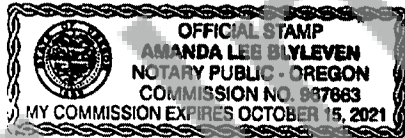
