STATUTORY WARRANTY DEED

Grantor(s), hereby convey and warrant to

Leroy W. Bruer,

Grantee(s), the following described real property in the County of Klamath and State of Oregon free of encumbrances except as specifically set forth herein:

The Easterly 105 feet of Lots 11 and 12 and the Easterly 105 feet of the Northerly 26.9 feet of lot 10, Block 48, Hillside Addition to the City of Klamath Falls, Oregon and more particularly described as follows:

Beginning at a point on the Northwesterly line of Lot 10, Block 48, Hillside Addition to the City of Klamath Falls, Oregon, which point is Northwesterly along said line a distance of 86.0 feet from the Southeast corner of said Lot 10; thence Southwesterly parallel to the Northwesterly line of said Lot 10 a distance of 105.0 feet to a point; thence Northwesterly parallel to the Northeasterly line of Lots 10, 11, and 12, Block 48, Hillside Addition to the Northwesterly line of Lot 12; thence Northeasterly along the Northwesterly line of said Lot 12 a distance of 105.0 feet to the Northeast corner of Lot 12; thence Southeasterly along the Northeasterly line of Lots 12, 11 and 10 a distance of 126.9 feet to the point of beginning.
