Beginning at a point in the Westerly boundary of said Section 11 distant 977.00 feet Northerly from the Southwest corner thereof; thence Southeasterly along a straight line making a Southeasterly included angle of 61* 46 1/2' with said Westerly boundary 531.9 feet; thence Southeasterly along the arc of a 1* 0' curve to the left, 2830.00 feet; thence Easterly on tangent 2141.00 feet, more or less, to an intersection with the Easterly boundary of said section 11 at a point distant 36.8 feet, Northerly from the Southeast corner thereof.
