SECOND AMENDMENT TO MEMORANDUM OF CONTRACT

This SECOND AMENDMENT TO MEMORANDUM OF CONTRACT ("Amendment") is entered into as of (10 28¹¹), 2019, by and among Swan Lake Moulding Company, an Oregon corporation ("Seller") whose address is Attn: Terry J. Scroggin, PO Box 428, Klamath Falls, Oregon 97601, and Michael Voight and Katherine Voight, husband and wife ("Purchaser") whose address is 2545 Watson Street, Klamath Falls, OR 97603.

On or about August 31, 2016, Seller and Purchaser entered into a Contract of Sale ("Contract") whereby Seller sold to Purchaser its interest in that certain property located in Klamath County, Oregon and more particularly described in Exhibit "A" ("Property").

A Memorandum of Contract was recorded with the Klamath County Recorder as document number 2016-009328 on August 31, 2016.

On or about February 28, 2018, Seller and Purchaser entered into an Amendment to Contract of Sale ("Amendment to Contract") to, among other things, extend the date on which final payment of principal and interest is due under the Contract to March 1, 2019.

An Amended Memorandum of Contract was recorded with the Klamath County Recorder as document number 2018-003895 on March 30, 2018.

On the date hereof, Seller and Purchaser entered into a Second Amendment to Contract of Sale ("Second Amendment to Contract") to, among other things, extend the date on which final payment of principal and interest is due under the Contract, as amended, to March 1, 2020.

All other terms upon which Seller sold the Property are set out in the Contract, Amendment to Contract and Second Amendment to Contract, to which reference is made for all purposes.
