QUITCLAIM DEED

KNOW ALL BY THESE PRESENTS that Susan L. Turner

hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and forever quitclaim unto James W. Surane III

hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, State of Oregon, described as follows (legal description of property):

That portion of the N 1/2 of the SE 1/4 of Section 33, Township 40 South, Range 10 East of the Willamette Meridian, lying South of the U.S.R.S. "C" Canal.

Excepting therefrom:

Beginning at the intersection of the West boundary of the Southeast 1/4 of said Section 33 and the South boundary of the U.S.R.S. "C" Canal; thence South, along said West boundary 296.0 feet; thence South 88° 26' East, along an existing fence line, 416.2 feet; thence leaving said fence, North 72° 18' East 591 feet, more or less to the South boundary of the U.S.R.S. "C" Canal; thence North westerly along said Canal Boundary to the point of beginning.
