SUBJECT TO: An easement for roadway purposes 30' in width along and parallel to the Southerly boundary of the above described property.

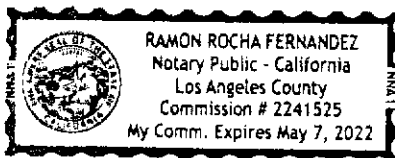
