Harris**, hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, State of Oregon, described as follows, to-wit:

Description of real property: THE EASTERLY 50 FEET OF THE SOUTHERLY 100 FEET OF THE FOLLOWING DESCRIBED REAL PROPERTY: BEGINNING AT A POINT WHICH A WEST 1180 FEET FROM CORNER COMMON TO SECTIONS 19, 20, 29 AND 30 IN TOWNSHIP 38 SOUTH, RANGE 9 E.W.M., THENCE 150 FEET WESTERLY ALONG THE SECTION LINE BETWEEN SECTIONS 19 AND 30 TO A POINT; THENCE NORTHERLY AND PARALLEL WITH SECTION LINE BETWEEN SECTIONS 19 AND 20 IN SAID TOWNSHIP AND RANGE, A DISTANCE OF 350 FEET TO A POINT; THENCE EASTERLY AND PARALLEL WITH THE SECTION LINE BETWEEN SECTIONS 19 AND 30, A DISTANCE OF 150 FEET TO A POINT; THENCE SOUTHERLY AND PARALLEL WITH THE SAID SECTION LINE BETWEEN SECTIONS 19 AND 20, A DISTANCE OF 350 FEET TO THE POINT OF BEGINNING.


To Have and to Hold the same unto grantee and grantee's heirs, successors and assigns forever.

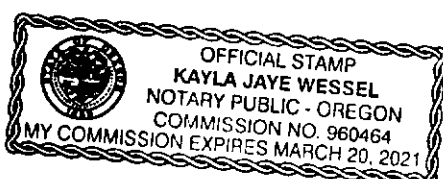


