The true consideration for this conveyance is other than money.

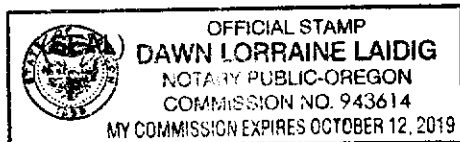
