PERSONAL REPRESENTATIVE'S DEED

THIS INDENTURE Made this 2nd day of April 2019, by and between Kevin Brink the duly appointed, qualified and acting personal representative of the estate of Bruce E. Brink, deceased, Probate Case No. 18PB02337, filed in Klamath County, hereinafter called the first party, and

Jon Rickey as to an undivided 50% interest and Joseph Kellar, as to an undivided 50% interest, hereinafter called the second party;

WITNESSETH:

For value received and the consideration hereinafter stated, the receipt whereof hereby is acknowledged, the first party has granted, bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the said second party and second party's heirs, successors-in-interest and assigns all the estate, right and interest of the said deceased at the time of the decedent's death, and all the right, title and interest that the said estate of said deceased by operation of the law or otherwise may have thereafter acquired in that certain real property situated in the County of Klamath, State of Oregon, described as follows, to-wit:

The Westerly one-half of Lot 598, Block 103, Mills Addition to the City of Klamath Falls, in the County of Klamath, State of Oregon.

The true and actual consideration paid for this transfer, stated in terms of dollars is \$39,500.00 PURSUANT TO AN IRC 1031 TAX DEFERRED EXCHANGE ON BEHALF OF GRANTOR/GRANTEE.

However, the actual consideration consists of or includes other property or value given or promised which is part / whole of the consideration.

TO HAVE AND TO HOLD the same unto the said party, and second party's heirs, successors-in-interest and assigns forever.
