Lot 3 of Kalina Addition to Malin, according to the official plat thereof on file in the office of the County Clerk, Klamath County, Oregon.

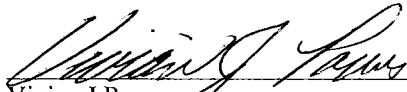

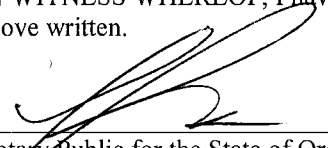
