Lots 68 and 69, Block 8 of Sprague River Valley Acres, as per plat recording in the records of said County.

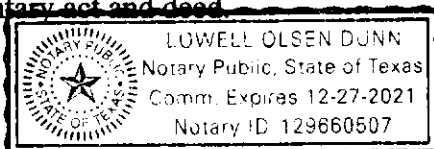

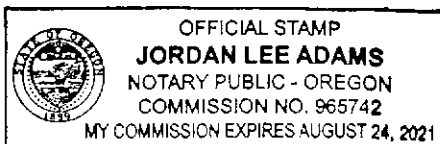
