KNOW ALL MEN BY THESE PRESENTS, That Valeri Rose Rychetsky, hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by Valeri Rose Rychetsky, Trustee of the Valeri Rose Rychetsky Living Trust hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

LOT 16, BLOCK 3, KLAMATH RIVER ACRES, Klamath County, Oregon, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.
