Lots 12 and 17, PLUM VALLEY II, according to the official plat thereof on file in the office of the County Clerk, Klamath County, Oregon.

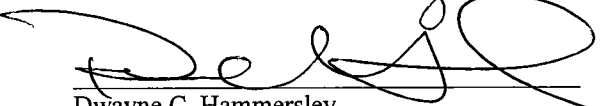

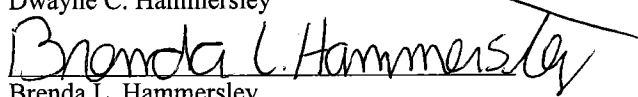

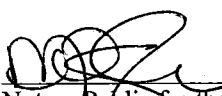
