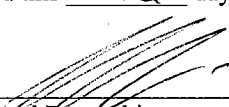
Lot 73 of Tract 1473, Pheasant Run, according to the official plat thereof on file in the office of the County Clerk, Klamath County, Oregon.

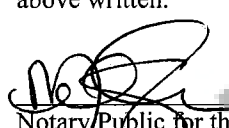
