THIS INDENTURE, Made this 08/06/2019, by and between Chris Kaber, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and KENT PEDERSON, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 18CV37964, Klamath County Sheriff's Office Number F19-0263, in which QUICKEN LOANS INC. was plaintiff(s) and KRISTIAN M. HILL; AMANDA R. WYLAND; STATE OF OREGON DEPARTMENT OF HUMAN RESOURCES SUPPORT ENFORCEMENT DIVISION; CARTER-JONES COLLECTION SERVICE INC. AND ALL OTHER PERSONS OR PARTIES UNKNOWN CLAIMING ANY RIGHT, TITLE, LIEN, OR INTEREST IN THE REAL PROPERTY COMMONLY KNOWN AS 1715 WINONA WAY, KLAMATH FALLS, OR 97603 was defendant(s), in which a Writ of Execution, which was issued on 12/11/2018, directing the sale of that real property, pursuant to which, on 02/27/2019 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$125,000.00, to KENT PEDERSON, who was the highest and best bidder, that sum being the highest and best sum bid therefore. 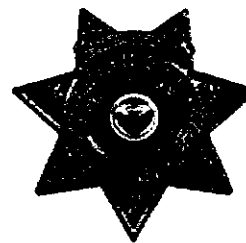

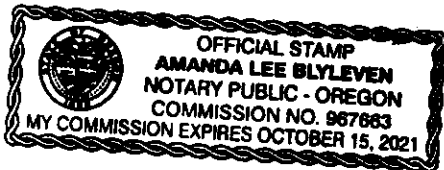
